

National Geographic “Yellowstone Live” Sweepstakes OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

SWEEPSTAKES DESCRIPTION: The National Geographic “Yellowstone Live” Sweepstakes (the “**Sweepstakes**”) begins on or about June 13, 2019, at 12:01 a.m. Eastern Time (“**ET**”) and ends on June 26, 2019, at 1:59 p.m. ET (the “**Sweepstakes Period**”). At the end of the Sweepstakes Period, one (1) Grand Prize winner will be selected, as set forth more fully below. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of National Geographic Partners, located at 1145 17th Street, NW, Washington, DC 20036 (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: Only legal residents of the forty-eight (48) contiguous United States and the District of Columbia, excluding Alaska and Hawaii, who are twenty-one (21) years of age or older at the time of entry are eligible to enter. Sponsor, Kaleidoscope Promotions Interactive, Ltd. (the “**Sweepstakes Administrator**”), their respective parents, subsidiaries, and affiliates, and each of their respective officers, directors and employees (collectively, the “**Sweepstakes Entities**”), and each of their immediate family members and/or people living in the same household are NOT eligible to enter the Sweepstakes or win the prize. This sweepstakes is void where prohibited.

HOW TO ENTER: You may enter the Sweepstakes by visiting the web site YellowstoneLiveSweepstakes.com (the “**Website**”) during the Sweepstakes Period, and following the instructions to complete and submit the entry form with the information requested. Limit one (1) entry per person and/or per e-mail address. All entries must be received by the end of the Sweepstakes Period in order to participate. The Website’s database clock will be the official time keeper for the Sweepstakes.

DRAWINGS AND WINNER NOTIFICATION: On June 26, 2019, one (1) Grand Prize winner will be randomly selected from among all eligible entries received throughout the Sweepstakes Period. The random drawings will be conducted by Sponsor or Sweepstakes Administrator, using randomization methods selected in its sole discretion. Odds of winning depend on the total number of eligible entries received. The potential winner will be notified by telephone and/or email using the contact information given at the time of entry, and will be announced on-air during the June 26 broadcast of Yellowstone Live on National Geographic Channel (pending verification of his/her eligibility). Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within three (3) days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. If any potential winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such potential winner will be disqualified and an alternate winner may be selected. Sponsor will successively attempt to contact up to two (2) potential winners of the prize in accordance with such procedure, and if there is still no confirmed winner of the prize in question after such attempts have been made, the prize may go unawarded.

GRAND PRIZE: One (1) Grand Prize is available (the “**Grand Prize**”). The Grand Prize is a trip for two (2) to visit Yellowstone National Park and stay at a National Geographic Unique Lodge of the World (the “**Trip**”). The Trip consists of roundtrip coach air transportation for two (2) on a carrier of Sponsor’s choice from the major airport closest to winner’s residence in the continental

U.S. to Bozeman, MT; round-trip ground transfer from Bozeman Yellowstone International Airport to the Lone Mountain Ranch in Big Sky, Montana; standard hotel accommodations at Lone Mountain Ranch for four (4) days / three (3) nights (double occupancy; room rate and tax only); and specified meals and activities listed [here](#). The Approximate Retail Value (the “ARV”) of the Grand Prize is Four Thousand Sixty-Five Dollars (\$4,065.00).

Actual value of the Grand Prize may vary depending on winner’s residence and time of travel. No cash alternative or prize substitutions will be allowed, except Sponsor reserves the right to substitute prize(s) of comparable value if the prize listed is unavailable for any reason. Prize may not be extended, transferred or refunded. Any included events, activities, or amenities are subject to availability. **Trip must take place December 6, 2019 – April 1, 2020, on dates falling outside the following blackout periods: December 21, 2019-January 2, 2020 and February 12-23, 2020.** Notwithstanding the foregoing, specific dates and times for travel shall be designated exclusively by the Sponsor. Certain travel restrictions, conditions and limitations may apply. Any stated difference between the approximate value and actual value of the Prize or any substituted prize will not be awarded. Grand Prize Winner and any non-minor Guest must have a valid and acceptable form of identification and at least one (1) major credit card in good standing. Hotels may require a credit card or cash deposit upon check-in. All costs and expenses not specifically listed herein, including but not limited to, gratuities, taxes, expenses, travel insurance, any local payment, beverages, meals, souvenirs, hotel services, side trips, optional extra activities, and any other incidentals not mentioned herein are the sole responsibility of Winner.

Odds of winning depend on the number of eligible entries received. The ARV of the all prizes is Four Thousand Sixty-Five Dollars (\$4,065.00 USD).

GENERAL PRIZE CONDITIONS: If any potential Grand Prize Winner is not able to take the Trip on Sponsor-approved dates falling between December 6, 2019 – April 1, 2020, on dates falling outside the blackout periods of December 21, 2019-January 2, 2020 and February 12-23, 2020, then the potential winner will be disqualified and an alternate potential winner will be selected. Grand Prize Winner’s Guest must be a minimum of thirteen (13) years of age at the time of travel, and a permanent lawful U.S. citizen and resident residing in the 48 contiguous United States or District of Columbia. If Grand Prize Winner’s Guest is a minor, Winner must be his/her parent or legal guardian. Grand Prize Winner and Guest must travel on the same itinerary. Sponsor assumes no responsibility for any damage to an entrant’s computer system which is occasioned by accessing the Website or otherwise participating in the Sweepstakes, or for any

computer system, phone line, hardware, software or program malfunctions, or other errors, failures, delayed computer transmissions or network connections that are human or technical in nature. Without limiting the generality of the foregoing, Sponsor is not responsible for incomplete, illegible, misdirected, misprinted, late, lost, damaged, stolen, or postage-due submissions or prize notifications; or for lost, interrupted, inaccessible or unavailable networks, servers, satellites, Internet service providers, websites, or other connections; or for miscommunications, failed, jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmissions; or for any technical malfunctions, failures, difficulties or other errors of any kind or nature; or for the incorrect or inaccurate capture of information, or the failure to capture any information. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes or the Website, to be acting in violation of these Official Rules, or to be acting in an unsportsman-like or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. No mechanically reproduced, illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted. In the event of a dispute as to the identity of the entrant, any on-line entry will be deemed submitted by the authorized account holder of the e-mail account from which it was sent, provided such account holder must still meet the eligibility requirements for the Sweepstakes. The authorized account holder shall be the natural person to whom the applicable email address has been assigned by the Internet access provider, service provider, or other online organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. The potential winner may be requested to provide the Sponsor with proof that the potential winner is the authorized account holder of the e-mail address associated with the winning entry. If a dispute cannot be resolved to Sponsor's satisfaction, the entry will be deemed ineligible. In the event Sponsor is prevented from awarding prizes or continuing with the Sweepstakes or a particular Sweepstakes drawing as contemplated herein by any event beyond its control, including but not limited to fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis (e.g. SARS), order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each a "**Force Majeure**" event or occurrence), then subject to any governmental approval which may be required, Sponsor shall have the right to modify, suspend, or terminate the Sweepstakes in its entirety or the affected Sweepstakes. If the Sweepstakes or a particular Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the winner[s] in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. Only the type and quantity of prizes described in these Official Rules will be awarded. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the number of each type of prize set forth in these Official Rules, the winners, or remaining winners, as the case may be, of the advertised number of prizes available in the prize category in question may be selected in a random drawing from among all persons making purportedly valid claims for such prize(s). Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. These Official Rules cannot be modified or amended in any way except in a written document issued in accordance with law by a duly authorized representative of Sponsor. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision.
